WE NEED CANDIDATES!

SO FAR NO ONE HAS ADVISED US THAT THEY ARE COMMITTED TO BE A DEMOCRATIC CANDIDATE FOR THE FOLLOWING OFFICES:

HOUSE DISTRICT 62: Incumbent, John Michael Montgomery, Republican.

This House District is made up of the following Comanche Co. precincts: Prcts. 1, 2, 3, 7, 8, 9, 11, 25 and 50/

HOUSE DISTRICT 63: Incumbent, Jeff Coody, Republican.

This House District includes the following Comanche Co. Precincts: 26, 29, 34, 35, 36, 37, 41, 42, 43, 45, 46, 48 and 51, plus a portion of Tillman County (think Frederick).

U.S. Congress, 4th Dist.: Incumbent, Tom Cole, Republican. Includes not only Comanche Co. but most of southwest Oklahoma, up to Norman.

Filing for the above seats is: April 13-15, 2016. Get your 2016 Candidate Filing Packet from Charles Kolker at the Comanche Co. Democratic Party office at 610A SW Lee Blvd., Lawton from 11 am to 3 pm, Monday through Thursday, or, go to: https://www.ok.gov/elections/candidate_info and download the 2016 Candidate Filing Packet. All the forms and information needed are in that packet. The filing forms require notarization and must be filed at the OK State Capitol Bldg. in OKC. The specifics are in the 2016 Candidate Filing Packet.

Lawton City Council seats, Wards 3, 4, 5

Ward 3: Incumbent, Rosemary Bellino-Hall, Republican.

Ward 3 includes Lawton precincts 8 and 17.

Ward 4, Incumbent, Jay Burk, Democrat.

Ward 4 includes Lawton precincts 31, 33 and 34.

Ward 5: Incumbent, Dwight Tanner, Independent.

Ward 5 includes Lawton precincts 20, 21 and 27.

Filing period: April 3, 4 and 5. NOTE! This is a **different filing period** than for the state and federal offices above mentioned. There's no filing fee for the city offices. Forms for filing can be obtained at the Comanche Co. Election Board, 315 SW 5th St., Lawton, Room 206. They require notarization.
